

ORDER



Defendant.

This matter comes on for hearing on the Court's own Motion requiring the parties to Show Cause why the above-captioned matter should not be dismissed for failure to prosecute and for failure to comply with local District Court Rules. The Court finds that the action was filed on August 16, 2010. The Court filed an Order dismissing the 5th, 6th and 9th Causes of Action on July 24, 2013. The Court notes that the case has been pending as of the date of this hearing 2,204 days. At the Show Cause hearing Plaintiff's Counsel asked for further time but was unable to provide any legal reason why the cause should not be dismissed for lack of prosecution. Other than an allegation that Counsel lost contact with the Plaintiff for a period of time (unspecified).

"The plaintiff bears the responsibility to prosecute a case with reasonable diligence. In the absence of a showing of good cause, a litigant's failure to

prosecute a civil action, resulting in noncompliance with the Nebraska Supreme Court's progression standards for civil actions in district courts, is a basis to dismiss an action on account of a lack of diligent prosecution." Marcuzzo v. Bank of the West, 290 Neb. 809, 825-26, 862 N.W.2d 281, 293 (2015).

"The district court has the inherent power to dismiss a case for failure to prosecute with due diligence." Marcuzzo, supra; see also Billups v. Jade,-Inc., 240 Neb. 494, 482 N.W.2d 269 (1992) (case dismissed after it was twice placed on the dismissal docket after months of inactivity in the litigation, but apparently escaped dismissal solely on the basis that the plaintiff would diligently prosecute the action).

Plaintiff filed his complaint in this matter on August 16,2010.

The Court finds in the interest of justice and in compliance with case progression standards the above-captioned matter should be dismissed.

IT IS SO ORDERED.
